WORKSHOP ON DISCIPLINARY & VIGILANCE PROCEEDINGS PRINCIPLES OF NATURAL JUSTICE OBSERVATIONS EMERGED DURING THE WORKSHOP

At the outset, we would like to thank you for inaugurating the workshop and imparting valuable knowledge/advises to the participants. The said workshop had been arranged from 26.08.2022 to 28.08.2022 with a view to train existing /new Defence Representative with enriched knowledge on the captioned subject. The threadbare discussions were held during the said workshop.

Traditionally, SBI has a robust system of adopting best practices of conducting fare departmental enquiries and always provided full opportunity to delinquent official to enable him to prove his/her innocence. Of late it is being observed from the Charge-Sheets being issued to officials that there are a number of shortcomings in the procedure being adopted as under:-

1. The Preliminary Investigation is not being carried out by the trained/skilled officers and many a times the said un-trained officers become judgmental despite the fact that they are suppose to mention the facts of the case(s) thus worsening the Preliminary Investigation Report.

2. The explanation(s)/Charge-Sheet(s) are issued on the basis of the said Preliminary Investigation Report(s) and the officers are punished harshly on the basis of the said Faulty Report(s).

3. The documents, rallied upon, are not provided along-with the Charge-Sheet to the Charge-Sheeted Officers (CSOs) despite the fact that the same is mentioned in the Charge-Sheet as enclosure(s).

4. The Preliminary Investigation Report is not provided to CSOs in the garb of Privileged Document violating the Principles of Natural Justice.

5. The documents are not being introduced on the floor of the enquiry proceedings through the witness(es)/custodian(s) and the Presenting Officers are entrusted with the task of introducing the documents depriving the fair opportunity to the DR/CSO of Cross Examination which is otherwise available to DR/CSO as per the Principles of Natural Justice.
